1. Public hearing for consideration of comments and suggestions concerning the request of the City of Chickasaw for the amendment of the attached specification for the classification of Public Safety Captain.
2. Public hearing for consideration of comments and suggestions concerning the request of the Water Works and Sewer Board of the City of Prichard for the adoption of Salary Grade 9, \$2,569.50 - \$4,107.74, for the classification of Fiscal Clerk I.
3. If Item Two is approved, the Water Works and Sewer Board of the City of Prichard requests approval for the creation of one (1) position of Fiscal Clerk I.
4. Have the Board set a date for a public hearing for consideration of comments and suggestions concerning the request from Mobile County for the following actions:
 - (A) Amendment of the attached specification for the classification of Training Specialist,
 - (B) Adoption of Salary Grade 15, \$2,914.01 - \$4,658.49, for the classification of Training Specialist.
5. The City of Prichard requests approval for an Extension of Administrative Leave for Jonathan Murphy, Police Officer, in excess of 60 days from January 21, 2018 to March 21, 2018. Mr. Murphy has been placed on paid administrative leave beginning November 22, 2017 through January 20, 2018.
6. The Mobile Area Water and Sewer System requests approval for an extension of the Injured with Pay for Charles Benning, Jr., Crew Chief, for the period of December 1, 2017 through February 1, 2018. Mr. Benning exhausted his 1,040 hours on December 23, 2016.
7. The Director reports receipt of a request from Ulytta Crosby for a supplemental written examination for Public Safety Dispatcher I. Ms. Crosby was absent for the examination on Thursday, January 11, 2018, due to her work schedule on the date of the examination.

 - (B) Creation of one (1) additional position of Automotive Service Worker I with the Mobile Area Water and Sewer System,
 - (C) Creation of one (1) position of Treatment Plant Operator II, part-time, with the Utilities Board of the City of Bayou La Batre.

Ms. Rahman will be attending a law conference that was scheduled and paid for prior to the confirmed date of the hearing and requests the hearing be rescheduled.

Have the Board ratify its approval of the request from Jay Ross, Attorney for Roderick Reed, to postpone the citizens' complaint hearing against Mr. Reed indefinitely until notified by Mr. Ross of pending charge resolutions for the citizen complainants. The hearing is presently scheduled for today, January 16, 2018.
